Guidance to Membership Grades:

- a) **Fellow:** Every candidate for election or transfer to the class of Fellow of the Society shall have attained the age of thirty-five years and, in the opinion of the committee, have made a significant contribution to acoustics or the profession of acoustics, through means demanding a sufficient knowledge of acoustics, as shall make it desirable that he/she be a Fellow of the society; and (1) have had experience of a least seven years of responsible work in acoustics or its applications which shall satisfy the committee; and (2) have the qualifications required to be Members of the society stated below.
- b) **Member:** Every candidate for election or transfer to the class of Member of the society shall have attained the age of twenty-five years and received a general education approved by the committee and either: (1) (a) have been educated in acoustics in a manner satisfactory to the committee and have obtained a degree or diploma recognized by the committee for the purposes of this clause of the Constitution, and (b) have had experience for at least three years in responsible work which demands a knowledge of acoustics or its application as shall satisfy the committee, or (2) (a) have satisfied the committee that he/she possess and equivalent knowledge of acoustics and cognate subjects considered appropriate by the committee in accordance with the provisions of Clause (1) of this rule, and (b) have had experience for not less than seven years of responsible work which demands a knowledge of acoustics or its applications as shall satisfy the committee, and (c) have been Associates for not less than three years.
- c) **Associate:** Every candidate for election or transfer to the class of Associate shall have attained the age of eighteen years and shall (1) have received a general education approved by the committee, and (2) (a) be a graduate in a discipline approved by the committee, or (b) be a technician in a discipline approved by the committee, or (c) be engaged or interested in acoustics or a related discipline, excepting always that (3) no person shall remain in the class of Associate if he/she fulfils the requirements to be Fellows or Members of the society.
- d) **Student:** Every candidate for election to the class of Student shall have attained the age of sixteen years and, at the time of application, be a bona-fide student in a subject related to acoustics, and who has complied with one of the following conditions: (1) satisfied the committee that he/she has received a good general education; or (2) passed a preliminary examination satisfactory to the committee.
